

SPA/Robert Lemelson Foundation (RLF) Student Fellowship

The SPA / Robert Lemelson Foundation Fellowships are designed to provide graduate students working in the field of psychological anthropology with funding to pursue exploratory research for planning their doctoral dissertation research and /or methods training to prepare for their doctoral dissertation research. Preference is given to applicants conducting exploratory research abroad. II. Michigan State University Funding Opportunities for MSU Graduate Students

MSU Graduate School - Funding Opportunities for Graduate Students – Includes assistantships, fellowships, and travel grants, plus students can obtain emergency funding and funds to top-off their current fellowship with funds from the university. <u>https://grad.msu.edu/funding/</u> and <u>http://grad.msu.edu/fellowships/</u>

• The MSU Council of Graduate Students (COGS) provides funding for conference travel, professional development, and leadership skill development. **Conference Grants** of up to \$300 are available to graduate and professional students once during their MSU academic career. For conferences taking place between July 1, 2020 and December 31, 2020, applications due by September 30, 2020. *Please note that travel is not eligible for compensation while University travel restrictions are in place. Expenses incurred for remote conferences are eligible.*

• **Professional Development Grants** of up to \$500 also are available to MSU graduate and professional students once in their MSU academic career. These grants should support students in attending events or engaging in activities that enhance their professional development. For conferences taking place

between July 1, 2020 and December 31, 2020, applications due by September 30, 2020. *Please note that travel is not eligible for compensation while University travel restrictions are in place. Expenses incurred for remote conferences are eligible.*

• **COGS Disciplinary Leadership Awards** provide graduate and professional students up to \$2,000 in recognition of disciplinary leadership. Faculty or others must nominate students. Consideration is given to students who have clearly demonstrated leadership in their respective disciplines and/or professional societies. MSU Dissertation Completion Fellowships – Contact the office of the college associate dean for research of your college to learn the college's procedure for awarding these fellowships. Dissertation to be finished during the one-semester tenure of the fellowship; the intent of the fellowship is to free up the student's time to devote his/herself to writing the dissertation, in preparation for the defense. 120 fellowships awarded annually. Award: \$7,000. *Deadlines: Varies by college. MSU Graduate Student Research Enhancement – Funds available to support research activities including travel to participate in workshops, data collection, short courses, and extramural laboratory rotations. Awards are intended to match/supplement funds provided by advisors, units, and colleges and will range from \$500-\$1,000. Only one request per student/tenure in degree program will be considered. *Deadline:* Rolling, decision on support will be made within three weeks of receiving all the necessary materials. https://grad.msu.edu/research-support

MSU Graduate School Leadership Development Fellowship - year-long, cohort-based program created to build a stronger and healthier graduate student community at MSU by preparing, supporting, and providing space for graduate student leaders to engage in change-oriented within their disciplines, College, the institution more broadly, and indeed the world. The program takes a holistic approach to graduate student professional development and success. This is a funded experience through which Leadership Fellows are supported through peer-networks, mentorship, and development opportunities. Fellows themselves range in terms of background, identities, and experiences. <u>More information and instructions on how to apply can be found here</u>.

Carole and Michael LeMense Family Endowed Graduate Fellowship - This fellowship will be awarded to Michigan State University students at graduate levels. Applicants will have graduated from a US public high school and have demonstrated academic excellence in their undergraduate studies. Two awards up to \$2,200 are available. Applicants must be pursuing degrees in Education, Healthcare, or Engineering. More information can be found here. *Most Recent Deadline: September 23, 2019.*

Barbara Stewart Thomas and Jim Thomas Graduate Fellowship - Barbara and Jim Thomas established this graduate fellowship for MSU students whose studies demonstrate the pursuit of "social justice for all." This fellowship offers freedom to the recipient whose passion for social justice can now be further explored by pursuing an advanced education, whether it is in the arts, humanities, social sciences, etc.

Title VI Foreign Language and Area Studies Fellowships (FLAS) – **MSU:** For studying a language and a foreign area or international development. Enrolled and new graduate students are eligible. Must be U.S. citizens or permanent residents. Awards available for tuition and fees during the academic year (stipends vary by center) and \$7,500 for summer language study. Only the **African Studies Center** offers these awards. (note that the Asian Studies Center no longer administers the FLAS program). MSU Alliance for African Partnerships - through the Partnerships for Innovative Research in Africa they are soliciting proposals for small grants (up to \$50,000), planning grants (up to \$100,000) and scaling grants (up to \$200,000) which include teams of MSU and colleagues from an African AAP university. Dr. Charles and Marjorie Gliozzo Dissertation Research Scholarship – Supports pre-dissertation visit to doctoral research site in a country outside the U.S. Applicants must be U.S. citizen or permanent resident and have completed sufficient academic credits in an MSU graduate program to have clearlydelineated dissertation research objectives and ideally have or are in the process of defended/defending their research prospectus/proposal. MSU Walker Hill International Scholarship – For predissertation visits to the site of the doctoral research in a country outside the U.S. (For international students, research in one's own country does not qualify.) Award amount depends on income generated by the endowment, but should be at least \$600 with the possibility of more funds if they are available. Whittier Endowed International Health Scholarship Fund – Awards of \$500 for MSU graduate students (Masters or PhD Level), students in the MSU College of Osteopathic Medicine or Human Medicine, or an MSU professional student for international health research (graduate level) or international health clerkships (Approved IIH international electives of 4-6 weeks for fourth year medical students.) May not

Gliozzo Scholarship Endowment in Global Health – Supports students who wish to study or conduct research in Africa, Latin America, Central America, or Asia. Donors particularly are concerned with health issues such as malnutrition, infection disease, malaria, HIV, poverty, and polluted water that are symptoms of larger social, political and environmental problems. MSU College of Education has several funding opportunities available to doctoral students. The Summer Research Fellowship funds more than 20 doctoral students annually, providing \$6,000 to support their research and scholarly development. The Summer Research Renewable Fellowship funds 8-10 doctoral students for two years, providing \$6,000 per summer. Faculty mentors receive an honorarium. The Summer Research Development Fellowship provides 15 first-year doctoral students with \$5,000 to develop or strengthen specific research skills and to acquire knowledge about specific methods not thoroughly developed in a regular course. The College's Research Practicum/Research Development Fellowship provides financial support to advanced doctoral students who have projected or incurred expenses relevant to data collection for their research. Fellowship amounts range from \$1,000-\$4,000. Outreach and Engagement Fellowships, Travel Funding, and other fellowships are also available. Deadlines: Doctoral students will be notified of the application process and deadlines in fall via the Ph.D. listserv. MSU College of Education – Marianne Amarel Fellowship by Center for Scholarship of Teaching and Teacher Education – Doctoral student must be enrolled in any doctoral program in College of Education at MSU; renewable up to 3 years. Nelson Mandela Museum/Michigan State University Museum Curatorial Fellowship Program – One curatorial fellowship to be completed during summer and fall semesters. Ten weeks of summer semester will be spent in South Africa (with at least eight weeks spent working full-time at the Mandela Museum in Mthatha) and the following fall semester will be spent working part-time at the MSU Museum. Fellows receive \$16,000. Up to an additional \$500 is available to attend a cultural heritage conference in South Africa and up to an additional \$1,000 to cover travel and conference registration costs to present results of fellowship experience or research. Curatorial fellows plan and complete projects in collaboration with and mentored by MSU faculty and professional museum staff at each institution. MSU Kellogg Biological Station (KBS) Long-Term Ecological Research (LTER) Graduate Fellowships -

1) LTER Capstone Graduate Fellowship: The fellowship is open to PhD students enrolled at MSU who are interested in extending their LTER-based research or in developing an aspect of their research to include LTER-related activities that would not otherwise be part of their dissertation work. Stipend of \$30,000 plus tuition and fees. Additional funds (up to \$5,000) will be available for travel or meeting expenses as warranted. 2) LTER Summer Research Fellowships: Two awards of \$6,250 each with up to \$500 for travel. Applicants must be MSU-based MSc or PhD students. 3) Small Grants: Students conducting graduate-level research are eligible to apply for up to \$2,000 for research-related expenses (but not salary or stipends). Priority will be given to those projects most closely aligned with overall LTER goals. MSU Annual Theodore Roosevelt Conservation and Environmental Leadership Fellowship – Annual award of approximately \$2,500 to support graduate and professional students as they prepare for leadership roles in natural resource and conservation-based organizations and agencies. Purpose of the fellowship is to enable individuals to participate in experiential leadership workshops and programs related to conservation of natural and environmental resources. MSU Gender, Justice, and Environmental Change (GJEC) Fellowships – Four \$10,000 fellowship opportunities for dissertation research and completion. Projects must address gender dimensions of environmental and/or agricultural change. Applicants must be Ph.D. students at MSU who are ABD. MSU Center for Gender in Global Context Graduate Student Travel Funding for Conference Presentations and Research Collection - On a rolling basis throughout the academic year, the GenCen awards travel grants to support students presenting at conferences (\$300) as well as students traveling to conduct research for the writing of their dissertation (\$500). Presentations or research must focus on women's and gender studies. <u>More information can be found here</u>.

Center for Latin American and Caribbean Studies (CLACS) Scholarship – Scholarship to support international research or study in Latin America. Funds may be used to support research, conference presentations, data collection, or dissertation write-up. MSU Sociology Graduate Students in International Development— Awards for graduate study in Sociology, including dissertation research abroad. Application requires 1) proposal and budget no longer than 5 pages for support of doctoral dissertation in the area of sociology of international development and 2) an endorsement letter from the student's dissertation chairperson. Check deadline (usually announced over the sociology listserv); submit application in either hard copy or electronic form to Shannon Davis, Office Supervisor, or Roseann Bills, Graduate Secretary, Sociology, 316 Berkey Hall. • Jay Artis Endowment Fund – For students who have <u>advanced candidacy (proposal approved</u>) and are planning research <u>about international development</u>. The maximum award is \$3,000. MSU Education Opportunity Fellowship (EOF) - The purpose of the Education Opportunity Fellowship (EOF) is to provide financial assistance to Michigan State University's graduate and professional students. Students must meet particular eligibility criteria and have a minimum undergraduate federal loan indebtedness of \$25,000 or more. <u>More information on application instructions and eligibility requirements can be found here</u>. Funds are allocated on a first-come, first-served basis for those who qualify until all funds are disbursed, so it is in your best interest to submit your application as soon as possible. *Last Deadline: April 15, 2020*.

MSU RCAH Cultures and Languages Across the Curriculum (CLAC) Fellowships - The RCAH is an interdisciplinary college with a strong commitment to social justice, civic engagement, the visual and performing arts, and languages and cultures. Graduate students selected for this fellowship participate in different components of the CLAC Program. Each fellow receives a stipend of \$4000/semester to help support CLAC research project expenses, professional development workshops, and/or travel to professional conferences. MSU UAW Cal Rapson Endowed Scholarship & Fellowship - The UAW Cal Rapson Endowed Scholarship and Fellowship fund is established for MSU students who meet the stated eligibility requirements and are pursuing any degree and are in or have a parent/guardian who is a member of the UAW. Awards may be up to \$2500 per academic year. The award is intended as general support for educational.... expenses and does not have to be repaid. <u>More information can be found here</u>. *Last Deadline*: *May 1*, 2019. **MSU Summer Institute and Digital Storytelling Graduate Fellows** - This summer institute allows selected faculty and graduate students to explore the pedagogic possibilities of three exciting, large-scale digital learning technology platforms at MSU: The Abrams Planetarium; 360 Degree Panoramic Room in the Library's Digital Scholarship Lab; Science on a Sphere (coming to the MSU Museum in Fall 2019). Digital Storytelling Graduate Fellows and their mentors will learn about the affordances and limitations of each facility and how they are best suited for different types of storytelling and data representation. Participants will collaborate towards innovative and interdisciplinary ideas for capitalizing on one or more of the platforms, and develop course modules that can engage students in novel forms of active learning in immersive digital arenas. All disciplines and interdisciplinary perspectives are welcome. Graduate fellows will receive a \$500 stipend for support projects.
